#### AMIE PONT - FRISBEE GOLF IN RANFURLY

MS PONT SPOKE TO HER IDEA OF CREATING A FRISBEE GOLF COURSE AT THE RANFURLY RAILWAY RESERVE. She gave an overview of the excellent speakers at this event, notably Sam Stubbs who spoke on opportunities for private capital, specifically superannuation capital to invest in public infrastructure.
- Attended the Affordable Housing summit, where there was also discussion on how homeowners on a low or fixed income might be able to leverage off some of the value of their property.
- Noted that this morning Council signed off the consultation document for 'Local Water Done Well', and commented that the document was a good introduction to the concept of a joint CCO, and that it also contained a useful myth busting factsheet and encouraged people to submit on this consultation.
